## **MEMBERSHIP CATEGORIES**

## **Regular Members**

Any partnership, company, or corporation that manufactures and, either directly or through a parent or subsidiary, sells sealing devices is eligible for election to Regular Membership in the Association. Applicants must provide a notarized certification verifying an annual sales volume of sealing devices of their own manufacture totaling \$500,000 (U.S.) or more in qualifying product categories.

#### Voting Representation

Each Regular Member must designate a voting representative authorized to vote on matters formally placed before the membership.

#### Definition of Sealing Devices

A sealing device is defined as a mechanism designed to prevent or control the escape of fluids or the entry of foreign materials. These devices are recognized by the Board of Directors as integral to the industry and are commonly used in:

- a. Applications involving shafts, rods, plungers, and valve stems in cylinders, pumps, and valves;
- b. Sealing flanged surfaces in pipes and equipment such as boilers and mixers;
- c. Controlling vibration and motion.

#### Definition of Manufacture

Manufacture involves processes such as machining, forming, shaping, molding, pressing, braiding, weaving, mixing, calendaring, coating, extruding, or curing raw or semi-finished materials. Merely cutting or forming finished or semi-finished materials without further processing does not constitute manufacturing.

## **Associate Members**

Any partnership, company, or corporation engaged in the business of manufacturing or supplying raw materials, equipment, or supplies used in the production of sealing devices is eligible for election to Associate Membership in the Association. This includes entities involved in testing raw materials, equipment, supplies, or products manufactured by Regular Members.

#### Voting and Participation Rights

Each Associate Member must designate a voting representative authorized to vote on association matters. Associate Members are entitled to attend meetings of committees or divisions they belong to or are invited to. Additionally, they may serve as Chair or Vice Chair of divisions or committees.

## **Distributor/Channel Partner Members**

A sole proprietorship, partnership, company, corporation, or business entity with no legal relationship or affiliation with any current Regular Member of the FSA and which takes title to stocks or inventories of sealing devices for resale is eligible for Distribution/Channel Membership. Members in this category must have a minimum annual sales volume of sealing devices totaling \$100,000 (U.S.).

Participation and Voting Rights

Distribution/Channel Members are entitled to attend meetings of any committee or division they belong to or are invited to. They also have the right to serve as Chair or Vice Chair of divisions or committees and to vote on matters formally placed before the association, division, or committee membership.

### **Affiliate Members**

Any partnership, company, or corporation engaged in publishing periodicals featuring articles, stories, and content focused on the fluid sealing industry and its products is eligible for election to Affiliate Membership in the Association.

Participation and Voting Rights

Affiliate Members do not have voting rights in association or division matters, nor may their representatives serve on the Board of Directors or hold office within the Association. They may attend committee or division meetings only by invitation.

### **Standards Partner Members**

Any partnership, company, corporation, sole proprietorship, or government agency that is an engineering firm providing services to sealing device manufacturers, distributors, channel partners, or end-users, or which is itself an end-user of sealing devices, is eligible for Standards Partner Membership in the Association.

Eligible Services

Standards Partner Members must provide one or more of the following services:

Sealing device systems engineering services

Process or facility design services

Procurement, project management, or construction services

Hydraulic or mechanical modeling services

Analytical methods services

Laboratory testing services

Field-testing services for facility owners, governments, or vendors

Participation and Voting Rights

Standards Partner Members do not have voting rights in association, division, or committee matters and are not eligible to serve on the Board of Directors or hold office in the Association.

Attendance at committee or division meetings is by invitation from the Chair, and Standards Partner Members are not eligible to serve as Chair or Vice Chair of a division or committee.
